How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons COMMERCIAL BANK chooses to share; and whether you can limit this sharing.

How does COMMERCIAL BANK protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • COMMERCIAL BANK does not share with nonaffiliates so they can market to you.	
Joint marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. COMMERCIAL BANK doesn't jointly market.
